Gem Summer Classic Rules and Participant Waiver

RULES

- 1. Gem Summer Classic will be under the direction of the Gem County Fair Board through their show manager, Karol Burlile.
- 2. Any exhibitor who violates any of the following rules will forfeit their premiums and privileges.
- 3. Premium payouts will be based on the number of paid entries and class size.
- 4. There will be no refund on entry fees for any reason.
- 5. Exhibitors are responsible for cleaning pens before leaving the grounds. Any pens **not** cleaned will cause exhibitor(s) to forfeit all premiums.
- 6. Only shavings are allowed as bedding and must be supplied by the exhibitor.
- 7. The show manager will handle any problems, questions, and situations before, during, or after the show that may arise, covered or not covered by the printed rules. Any/All decisions made will be at the direction of the show manager(s). Decisions made will be final and not subject to appeal.
- 8. The show is open to ages 2 and up in all market and breeding divisions. Showmanship will be 4-H/FFA youth as of January 1st with a special PeeWee division. (see division breakdowns for ages)
- All market and breeding livestock will be weighed in with exception of heifers, they will be classed by Angus, Hereford, and AOB by age. Classes will be set after the completion of the weigh-in.
- 10. All livestock from outside of Idaho must have proper health papers. CVI must include Gem County Fairgrounds, 2199 S Johns, Emmett, ID. 83617. Health ID GSC2023.
- 11. All animals must be free of diseases. Gem Summer Classic reserves the right to require the removal of any animal due to health concerns.
- 12. All animals brought for exhibition are at the owner's risk. The show management will not be held responsible for injuries incurred by animals or injuries or damages inflicted on a third party by said animals and in no event will be held liable for the death of an animal.
- 13. All exhibitors must wear appropriate show attire, open-toed shoes, tank tops, crop tops, and shorts are prohibited.
- 14. Glass bottles are prohibited on the premises.
- 15. Dogs are prohibited on the premises.
- 16. All exhibits will be under the control of the show management. The Gem Summer Classic WILL NOT BE RESPONSIBLE for any loss or damage that may occur.
- 17. If an animal gets loose in the show ring, an exhibitor will be given two chances to regain control of said animal throughout the duration of that particular show. Upon the third instance, the exhibitor and the animal will be dismissed from the show ring.

COST

EARLY BIRD ONLINE/MAIL ENTRY FEE per entry is \$35 and Showmanship \$10 if processed by May 15th. Must be postmarked by May 15th to receive the early bird fee.

ONLINE/MAIL ENTRIES processed by June 7 are \$40 per head and the Showmanship fee is \$15.

There is a \$5 ground fee per head.

Day of show entry: \$45 per entry and Showmanship \$20 per entry.

Show Circuit.

WAIVER

- 1. **ASSUMPTION OF RISK**. Participant and/or the undersigned understand that there are many known and unknown dangers and/or risks associated with participation in show activities and hereby grants a general release for the participant and/or the undersigned and any heirs, executors, administrators or assigns and participant and/or undersigned waive, remise, and forever discharge and release Gem County, Gem County Fair Board, the show manager, and any and all elected or appointed officials, administrators, officer, employees, volunteers, agents, insurers and any other individuals or entities affiliated with such persons and/or entities from any and all claims, severable or otherwise, past, present or future which can or may ever be asserted as a result of any injuries or damages, physical or mental, sustained by the participant while participation in the show activities.
- 2. **RELEASE**. Participant and/or the undersigned release and discharge Gem County, the Gem County Fair Board, the show manager or designee from any liability of any nature for any property damage or personal injury suffered by the participant and/or undersigned on the Gem County Fairgrounds premises, including personal injury and the loss, injury or destruction of property, animals or livestock from any cause.
- 3. **INDEMNIFICATION**. Participant agrees to indemnify, defend, and hold harmless Gem County, the Gem County Fair Board, the show manager or designee and its officers, agents, and employees, from and against any and all claims, losses, actions, or judgments for damages or injury to persons or property arising out of or in connection with the acts and/or performances or activities of the participant, the undersigned, participant's agents, employees or representatives under this waiver
